## Installation Service For The Presbytery Moderator Rev. Marty Simmons

**Current Moderator:** There are a variety of gifts, but it is the same Spirit who gives them. There are different ways of serving God, but it is the same Lord who is served. God works through each person in a unique way, but it is God's purpose that is accomplished. To each is given a gift of the Spirit to be used for the common good. Together we are the body of Christ, and individually members of it.

#### **Statement on Ordination**

We are all called into the church of Jesus Christ by baptism and marked as Christ's own by the Holy Spirit. This is our common calling, to be disciples of Jesus Christ and servants of our servant Lord. Within the community of the church, some are called to particular service as deacons, as ruling Elders, as ministers of Word and Sacrament.

Marty Simmons, in baptism you were claimed by the love of God, clothed in the grace of Jesus Christ, and anointed with the gifts of the Holy Spirit to share Christ's mission in the world. Now you are called by God through the voice of the church for new service in Jesus' name. You have been elected by this body to serve as the Moderator of Providence Presbytery. This service is for one year, unless called upon by the body to be moderator appointed if future moderators cannot serve. Today we gather to install you in this office.

In accordance with the Constitution of the Presbyterian Church (U.S.A.), show your commitment to this calling by responding to these questions:

- a. Do you trust in the Lord Jesus Christ your Savior, acknowledge him Lord of all and Head of the Church, and through him believe in one God, Father, Son, and Holy Spirit? **I do.**
- b. Do you accept the Scriptures of the Old and New Testaments to be, by the Holy Spirit, the unique and authoritative witness to Jesus Christ in the Church universal, and God's Word to you? I do.
- c. Do you sincerely receive and adopt the essential tenets of the Reformed faith as expressed in the confessions of our church as authentic and reliable expositions of what Scripture leads us to believe and do, and will you be instructed and led by those confessions as you lead the people of God? I do and I will.
- d. Will you fulfill your ministry in obedience to Jesus Christ, under the authority of Scripture, and be continually guided by our Confessions? I will.
- e. Will you be governed by our church's polity, and will you abide by its discipline? Will you be a friend among your colleagues in ministry, working with them, subject to the ordering of God's Word and Spirit? I will.

- f. Will you in your own life seek to follow the Lord Jesus Christ, love your neighbors, and work for the reconciliation of the world? **I will.**
- g. Do you promise to further the peace, unity, and purity of the church? I do.
- h. Will you pray for and seek to serve the people with energy, intelligence, imagination, and love? I will.
- i. Will you be a faithful Moderator, watching over the people, providing for their worship, nurture, and service, and will you try to show the love and justice of Jesus Christ? I will.

### Question to the presbytery:

- a. Do we, the members of the church, accept Marty Simmons as the Moderator of Providence Presbytery, chosen by God through the voice of this presbytery to lead us in the way of Jesus Christ? **We do**.
- b. Do we agree to pray for her to encourage her, to respect her decisions, and to follow as she guides us, serving Jesus Christ, who alone is Head of the Church? **We do.**

### Let us pray:

Gracious and eternal God, with joy we give you thanks and praise. Throughout the ages and in every place, you have chosen servants from among your people to point the way to salvation by your grace. We are grateful for ancestors in the faith who followed without fear, placing their trust in you alone— for judges and monarchs who ruled in righteousness and peace; for prophets and apostles who spoke your bold words of mercy and of truth; for leaders and teachers in every age who have nurtured your people in faith and faithfulness. Above all, we praise you for Jesus Christ, who came not to be served, but to serve, and to give his life to set others free. Anointed by your Holy Spirit, Christ proclaimed your reign on earth, revealing your saving love in all he said and did.

Gracious God, pour out your Spirit upon your servant, Marty, whom you called by baptism as your own. May she continue in the ministry to which you have called her. May she rely on the gifts of your Spirit, following Christ faithfully in this calling. Empower her to build up the church, to strengthen the common life of your people, and to lead with compassion and vision. This we pray in Jesus' name. Amen



## A Report to the Stated Meeting of Presbytery, February 2024

Greetings in the name of our Lord Jesus Christ!

One of the ways I'm working to get to know you is through 'county coffees.' I've set up, most Tuesdays, opportunities in each county for you to swing by and say hello, sit down and introduce yourself. Another avenue is through worshiping with you. Most Sundays I'm out and about (and post about it on our Facebook page!) worshiping with the saints of Providence Presbytery. I've worshiped at Camden Second Presbyterian, and Unity Fort Mill. I've been to First Rock Hill, and Fishing Creek PC. Sometimes I get to lead worship (Allison Creek so far) which I love to do as well.

Another way is through our Community meetings, mostly via Zoom. I'd like to see the Communities commit to at least a couple of meetings in person in 2024, to begin reconnecting and enjoying one another's company. I've joined Zoom meetings with other Synod execs – but we also met in person in early January.

Most importantly, though, is our work to help you get to understand our new way of operating. The presbytery office is no longer on Oakland Avenue. The business administrator works out of a small space in the Tirzah church (thank you!!) and your new Stated Clerk (thanks, David Bender!) and I both do our presbytery work remotely. Committees are now Communities, and YOU are encouraged to plug in where your passions lead you, because YOU are Providence Presbytery!

#### Providence Presbytery Community of Love Coordinating Team Report to Providence Presbytery February 11, 2024

### Items for Information

- On November 2, 2024, the Coordinating team approved Rev. Dr. Toby Mueller as Bridge Executive Presbyter of Providence Presbytery. Her first day of work was November 6, 2024. Her terms of call include a salary of \$40 per hour and not more than \$4,000 per month, which averages 20-25 hours per week. She brings a vast array of experience working in several positions in a variety of church settings, and she has served at the Presbytery level. She has worked with ministries in transition, and she brings a package of experience, energy and expertise that is serving Providence Presbytery very well. Welcome Toby!
- The Coordinating team approved a Presbytery E-mail Voting Policy which can be used by Presbytery Communities of Care and ministry teams. This policy can be found in this packet. (See Page G: 4)
- The team reviewed and agreed with a document outlining the basic structure of Providence Presbytery and the names by which the Communities of Care, ministries etc. will be called. That chart can be found in this packet. (See Page G: 5)
- For the PC(USA) General Assembly, the following geographical boundaries of Providence Presbytery were approved: "The geographic district of the Presbytery of Providence consists of the counties of Lancaster, Union, Chester, Kershaw, and York; the township of Blacksburg (within Cherokee County) all in the state of South Carolina; and Union (the portion delimited by Waxhaw Highway, Old Waxhaw Monroe Road, South Providence Road, Lancaster Highway, and the North Carolina/South Carolina border), in the state of North Carolina."
- Providence Presbytery received two overtures to General Assembly, one from Charleston Atlantic Presbytery and the other from Greater Atlanta Presbytery. The Coordinating team approved the appointment of the commissioners from the 2022 GA and those who are going to the 2024 GA as a Committee on Bills and Overtures to study these overtures and to recommend action by Providence Presbytery on them.
- Updates on Administrative Commissions

## • Fort Lawn and Cedar Shoals

The Administrative Commission members for Cedar Shoals Presbyterian Church and Fort Lawn Presbyterian Church are Megan Watson, Dickie Harper and Robert Folks. They are charged with respectfully closing those two churches.

#### Cedar Shoals

The commission is in conversation with the last remnants associated with that congregation. They have reviewed the property and assets. They are in conversation with a Cemetery Association located across the street from the church property that is interested in acquiring it. They are making good progress.

### • Fort Lawn

The commission is in conversation with the last members of Fort Lawn. They are gathering information regarding the church ministry and assets, and they are aware of a Community Center who is interested in acquiring the property. Their work continues.

#### o Oakdale

The Administrative Commission members for Oakdale Presbyterian Church are Steve Austin, Linda Kennedy, Marty Simmons, Tim Cureton, Geoff Dunn, Shirnetha Belk and David Bender. The commission has met with the Oakdale session and congregation and has exchanged many correspondences. The commission unanimously agrees that the Oakdale congregation believes they can no longer remain a part of the PC(USA), and the commission is working towards transferring them to ECO. The administration presented the session with proposed terms for a Covenant Agreement which includes Terms of Dismissal. Negotiations with Oakdale continue.

#### • Mt. Tabor

The Administration Commission members for Mt. Tabor Presbyterian Church are Christina Trimble, Paul Smith, Mike Conn and Doug Macdonald. They have met several times with the Mt. Tabor session. The commission has come to the conclusion that the Mt. Tabor congregation believes they can no longer remain a part of the PC(USA). The commission has asked Mt. Tabor to proceed with their conversation towards acceptance into another Reformed denomination. The commission has also asked Mt. Tabor for further information necessary to begin to form Terms of Dismissal. As of the date this report was submitted, they await Mt. Tabor's response.

#### o Bethesda in Camden

Presbytery staff has received a letter signed by what we believe to be all of the ruling elders of Bethesda (K) Presbyterian Church seeking to disassociate with the PC(USA) and Providence Presbytery and to become a congregation of another as of yet unnamed Reformed denomination. Presbytery staff has acknowledged receipt of that letter and begun gathering an Administrative Commission to work with the Bethesda (K) church.

#### **Items for Action**

1. The Community of Love moves the approval of these ruling and teaching elders to serve on an Administrative Commission to work with the Bethesda Presbyterian Church in Camden regarding their desire to disaffiliate with the PC(USA):

Joanne Sizoo(TE from Grace (Y))Hope Moore(RE from Tirzah (Y))Tim McCullough(RE from Pleasant Ridge)Tom Robinson(retired TE--member of Presbytery)Dannie Vaughn(RE from Unity)

# 2. <u>The Community of Love moves that this Administrative Commission be granted the following authority</u>:

This commission is entrusted with the following authority: (1) to enter conversation with the Bethesda (K) session to determine their reasons for seeking disaffiliation (2) to determine whether the denomination with which the church seeks to affiliate meets the Book of Order criteria for transferring membership (3) to determine whether the church congregation membership supports the desire to disaffiliate from the PC(USA) (as determined by a vote of their active membership of 75% or higher) (4) to determine whether any church members desire to remain members of the PC(USA) and, if so, to work with them to allow them to do so (5) to determine whether there is a schism within the membership of the church congregation and, if so, to take action as set out in G-4.0207 (Book of Order) (6) to inquire into the value of the Church property and assets in order that we do due diligence in our fiduciary responsibility to the PC(USA) (7) to negotiate terms of dismissal with the church session which will be included in a Covenant agreement between Providence Presbytery and Bethesda (K) Presbyterian Church (8) to determine whether the Bethesda congregation accepts the terms of the Covenant agreement (as determined by a vote by their active membership of 75% or higher) (9) if the terms are approved by the congregation, to bring said terms before the body of the Presbytery for vote (10) to take original jurisdiction only if it is determined that the "session of the congregation is unable or unwilling to manage wisely its affairs."

## Voting By Electronic Means

When a motion needs to be voted on between meetings of expediency, The Moderator of the Committee shall first acquire a Committee mover of the motion and a second, then shall write out the motion in full with rationale and send it to the Committee Members.

Committee and subcommittee matters may be acted upon by email or text message vote, so long as the following criteria are met:

- 1. Only one item or subject is put forward for a vote by the Moderator of the committee;
- 2. The committee member who makes the motion and the committee member who provides the second to the motion are both named in the communication;
- 3. This policy is included in the body of the communication;
- 4. The item for action does not go beyond the bounds of the approved committee budget; and,
- 5. The item does not include information of a sensitive nature that requires confidentiality.
- 6. The motion is put forward for a defined voting period (*typically 3 days*);
- 7. Voting <u>may</u> be conducted using a polling system (*like Doodle Poll for email or PollEverywhere for text messages*) for the collecting and recording of the votes;
- 8. An abstention is recorded by either an 'abstain' vote in the polling system or by an automated 'out of office reply' which would be counted as a vote to abstain;
- 9. If any member raises a question or objects to the motion, e-voting ceases and a called meeting is required (*may be by electronic means*);
- 10. A quorum must be present among voting members. A simple majority is required for vote completion and must meet the requirements of a quorum for passage or failure;
- 11. The results of the e-vote are reported by the Moderator to the members of the committee once voting has ended;
- 12. The vote tally is recorded in the minutes of the closest committee meeting under the appropriate sub-committee or section.

# Faith Statement *Paul E. Smith, Jr.*

### Coming Under the Care of the Committee on Preparation for Ministry of Providence Presbytery

#### Steps to Ordination as a Minister of Word and Sacrament

The care process is a covenant between three partners- you, your session, and the Presbytery. We will work together throughout your time as an inquirer and candidate, but in many regards, you are required to take ownership of this process. Ministry is a profession where pastors are called to recognize what needs to be done and then make sure it happens. Most of what you will be asked to do by the Presbytery is asked of everyone going through the process to become a Ministry of Word and Sacrament, but Presbytery may have some specific requirements for you as an individual. These individual requirements will be geared toward helping you develop your sense of call and your gifts.

The first two steps, Inquiry and Candidacy, are distinct phases in which you grow in listening to and responding to God's potential call for you to ministry. The Book of Order requires that Inquiry and Candidacy together last at least two years, one year of which must consist of Candidacy (G-2.0604). The last two steps are procedural in nature and serve to certify you for a call in the Presbyterian Church (USA) as discussed below. In addition to this letter, you will want to become familiar with section G-2.06, "Preparation for Ministry," in the Book of Order of the Presbyterian Church (USA) and the resources on Preparation for Ministry provided on our denomination's webpage. Links to both are included here... *Advisory Handbook* at [Resources - Advisory Handbook for Preparation for Ministry in the Presbyterian Church (U.S.A.)] and *Book of Order* at [2023-2025 Book of Order]

#### Pre-Inquiry Time Frame

To begin the process of Inquiry, you will need to be a member of a church in Providence Presbytery and active in that church for 6 months. You will also need to complete <u>1A-D</u> as well as <u>2B</u>. These forms require that you be endorsed by the Session of the congregation of which you are a member. (You can also find these forms and all necessary forms for the ordination process on our Presbytery's website). It cannot be overemphasized that strong communication between you and your Session is important during the whole ordination process. An active elder on the Session will act as your Session Liaison to be a connector for communicating with you and where you are in the process and to communicate updates to your Session.

After your Session endorsement and after completing the required paperwork, you will appear before CPM. If you are approved by the CPM, the Presbytery will officially vote to enroll you as an Inquirer at its next stated meeting. (Please note that you do not need to attend that meeting.)

#### <u>Inquiry</u>

The purpose of the inquiry phase for you, as you are discerning God's call to serve as a Minister of the Word and Sacrament, includes exploring your sense of call in community in service to the church. The Presbytery in process with the Committee on Preparation for ministry joins you as together we discern your suitability and, finally, your readiness for ordered ministry.

Once you become an Inquirer, the CPM will appoint a liaison to assist you. The liaison's responsibility is to be a guide, coach, and helpful resource for you throughout the ordination process. You should feel comfortable going to your liaison should you need answers to specific questions, general advice in the ordination process, or someone to be a sounding board for any issue you encounter as a part of the care process. They will be praying for you throughout this process, so feel free to share specific prayer requests.

During Inquiry, you will also need to:

- immediately provide transcripts showing graduation from a regionally accredited college or university and any other graduate course work;
- schedule your psychological evaluation and assessment. This must be done before you become a candidate. It is our hope that your church's session will help pay this fee;
- upon completion of Old and New Testament introductory classes, take the Bible Content Exam.
- complete a background check- contact Presbytery office for release form
- provide a certificate of completion of boundary training, which includes the topic of sexual misconduct, and child sexual abuse prevention training with recertification at least every thirtysix months. The presbytery shall determine which trainings are approved to meet the criteria of these two requirements. (G-2.0603)

## <u>Candidacy</u>

When should you apply to move from Inquiry to Candidacy? The short answer is, when you:

- have been an Inquirer for at least one year,
- have successfully completed your career and psychological testing,
- further discerned your call and your gifts for ministry is validated by yourself, by the CPM, and by others when you have had enough course work and experiences in church and church-related settings to have refined your sense of call,
- concluded that you believe that in order to respond to God's call to service, you need to be
  ordained as a Minister of the Word and Sacrament. (Many people may help you discern when
  you are ready to become a Candidate your pastor and other ordained clergy, your seminary
  professors, internship supervisors, friends, family, and your liaison, to name a few.)

The purpose of the Candidacy phase is to provide for the full preparation necessary to be a Minister of the Word and Sacrament, and for the Presbytery to assess your fitness for ordered ministry. While the Inquiry phase was a time for exploring many possibilities and directions (while evaluating your strengths and growth areas), the move to Candidacy reflects a clarifying of focus, more certainty about purpose, direction, and self-awareness. In fact, the move calls for a recommitment with your partners in the covenant: your congregation and the CPM.

When you and your liaison feel ready to move to Candidacy, you will need to:

• arrange for an appointment with the CPM

- complete forms <u>5A & 5B</u>, some of which again require Session endorsement;
- submit a brief Statement of Faith no more than one typed page). Students should treat this as their "Apostles' Creed" type statement. It should address the Trinity (God as Father, Son, and Holy Spirit), the authority of Scripture, both sacraments, and the significance of the church;
- and submit a current, official copy of your academic transcript to the Presbytery Office.

Upon Session endorsement and completing the required paperwork, you will appear before the CPM.

In addition to the forms above, you will also need to provide thoughtful, written responses to the following questions. Your responses should articulate a clear understanding of Reformed Theology.

- 1. Articulate an understanding of Christian vocation in the Reformed Tradition and how it relates to your own personal sense of call.
- 2. Express your personal faith in a manner that demonstrates an understanding of the Reformed Tradition.
- 3. Expound upon at least one concept from your personal faith statement (Question #2) at greater depth, explaining what your faith means about God, humanity, and their interrelationships.
- 4. Explain what it means to be Presbyterian, indicating how that awareness grows out of participation in the life of a particular church.
- 5. Discuss your personal and cultural background as it relates to the Ministry of Word and Sacrament, including concern for maintaining your own spiritual, physical, and mental health.
- 6. Express your understanding of the tasks that Ministers of the Word and Sacrament perform, including expression both of your specific gifts for this particular ministry and areas in which further growth is needed.

Please remember that all required paperwork, including that from third parties, should be in the hands of the CPM co-chairs one week prior to your meeting with CPM.

If you are endorsed by both your Session and the CPM, the Presbytery will vote to enroll you as a Candidate at its next stated meeting. You must present a written statement of faith to be printed in the packet for the Presbytery and deliver an oral statement of call before the Presbytery. The moderator will then open the floor for questions, which will be related to your sense of call. Since you must be physically present at the Presbytery meeting, please plan on coordinating your appearances before your church's Session, CPM, and the next stated meeting of Providence Presbytery. Dates of Presbytery meetings are on the <u>Providence Presbytery website</u> or your Session liaison can share those dates with you.

Once you become a Candidate:

- 1. Fill out forms <u>5C & 5D</u>
- Pass the standard ordination exams (Theology, Polity, Worship and Sacraments, and Exegesis). We do require students to become a Candidate before taking these ordinations exams. You are responsible for paying the fees for these exams. <u>Register</u> <u>here</u> and one of the Co-Moderators of CPM will be notified in order to grant permission for you to take the exams.

### Required Courses

You must graduate from and provide a final, official transcript from a theological institution accredited by the Association of Theological Schools. Your classes must include:

- 1.) Greek and Hebrew Languages
- 2.) Exegesis in Greek and Hebrew
- 3.) Introductions to the Old and New Testaments
- 4.) Reformed Theology
- 5.) Worship and Sacraments
- 6.) Preaching
- 7.) Polity
- 8.) Supervised Ministry
- 9.) Clinical Pastoral Education (CPE)

If you are not attending a seminary of the PC (USA), you may be required to take Reformed Theology, Polity, Worship and Sacraments, and Preaching at a seminary of the PC (USA). You will also need to provide the CPM with copies of all supervised ministry (parish and/or non-parish) assessments. These are the core requirements. In some cases, based on the individual, CPM might require additional classes or experiences.

#### Annual Consultations

In addition to meeting with the CPM for approval as an Inquirer and a Candidate, you will also need to meet with the CPM for annual consultations. You will need to complete Form 3 for this consultation and submit a current, non-official copy of your academic transcript to the Presbytery Office. These meetings do not require Session endorsement, but they are required to remain under care. If scheduling and travel are an issue, these consultations may be done online through a program such as Zoom or Skype. To arrange your annual consultation with the CPM, please email the CPM co-chairs.

#### Sexual Misconduct Prevention Training - (Developing Healthy Boundaries Training)

All active ministers, Commissioned Local Pastors (CLPs), certified educators, Candidates/Inquirers under our care, Committee on Ministry (COM), CPM, and Permanent Judicial Commission (PJC) members are required to attend sexual misconduct training. To ensure participation, COM will not attest or re-attest Ministry Discernment Profiles (MDP's), CLPs will not be commissioned nor will qualified Candidates/Inquirers be allowed to serve congregations. This training may be done at your seminary or through the Presbytery. Certification as to the date, location, and time that you took the training should be given to the CPM chair for inclusion in your file.

#### Seeking Any Position in a Church or Non-parish Setting as an Inquirer or Candidate

While the CPM believes that service in a local church or non-parish setting can be a valuable experience, it is required that students under the care of this Presbytery inform their CPM Liaison of such conversations before negotiating and accepting a position. Members of the CPM are here

to guide you in these opportunities for your own protection and for the good of the church or agency you are seeking to serve.

## Final Assessment

After you have been a Candidate for at least one year, passed the standard ordination exams, and have completed all other requirements for ordination, you will once again meet with the CPM for a final assessment during which you will be certified ready to receive a call. This is an oral exam that covers Theology, Worship and Sacraments, Polity, and Biblical Knowledge (G-20607c). This meeting with the CPM does not require Session endorsement. No paperwork is required unless it has been over a year since the Candidate met with the Committee. If it has been over a year, the Final Assessment will be combined with an Annual Consultation and Form <u>3</u> will be required. It is essentially a review to ensure that you have completed (with the exception of your theological degree) and have submitted all requirements for certification as ready to receive a call. Only after you are certified ready to receive a call may you distribute your Ministry Discernment Profile (MDP), enter into formal conversations, and accept a call from a church or validated ministry (G-2.0503a; G-3.0306 at [2023-2025 Book of Order] )

The CPM shall record when it has certified you ready for ordination, pending a call. In addition to this final assessment, you will also need to be approved by your calling Presbytery's Committee on Ministry (COM). Contact the Committee on Ministry (COM) of the calling Presbytery, so that they too may interview you regarding the call and approve the terms of call prior to the Presbytery meeting at which you will be examined. The Presbytery placing the call to the candidate for ministry shall ordinarily examine, ordain, and install the candidate.

After you have met these requirements, you will preach a sermon, 10 minutes in length, before the Presbytery, or representatives thereof, in which you are receiving your call and be further examined on your sermon and Statement of Faith on the floor of that Presbytery meeting. The CPM's part of your journey ends, and you will arrange with the Committee on Ministry the details for your ordination and installation.

#### Important Additional Information

As we partner together in support of students and for the good of the church as a whole, it is expected that a student under care of the CPM complete the pathway to ordination in no more than a 10-year time span. Please also be aware that the Presbyteries' Cooperative Committee on Examinations advises presbyteries that ordination exams cannot provide meaningful information about an individual's current "readiness to begin ministry" for a period of more than five years. Consequently, it may be advisable to have candidates repeat ordination exams more than 10 years to complete the care process and those who passed ordination exams more than 5 years ago may be asked to partner with the pastor and Session of their home church, their CPM liaison, and the CPM as a whole to engage in an intentional time of discernment to gain a clearer understanding of God's calling to the Ministry of Word and Sacrament. If a student chooses to withdraw from the care process and reengage at a later time, the student may be required to start the care process over beginning with the Inquirer phase.

In order to fully support, care for, and pray for one another, students are expected to stay in

regular contact with the CPM through their assigned liaison. A failure to stay in regular communication with the CPM at a minimum of a yearly basis may result in that student being removed from the care process.

# HELPFUL HINTS FOR PRESBYTERY COMMISSIONERS

Congratulations on being chosen to be a commissioner to this Presbytery meeting from your congregation! Below are some thoughts and observations that you may find helpful as you prayerfully prepare to fulfill your responsibility.

- Our Presbyterian system is a very simple system: It assumes that Christians meeting in representative bodies, which we now call **councils**, can seek, and know the will of God and that, through these councils, the whole church can be governed in ways that are just, decent, and orderly.
- Officers elected to serve as commissioners to a meeting of the Presbytery cannot be told how to vote. Our Book of Order reminds us that "Christ alone rules, calls, teaches, and uses the Church as he wills." (F-1.0202)
- Officers must be free to listen for the word of Christ to his church. As commissioners you are independent decision makers and cannot be bound to vote according to the wishes of those who elected you. Again, our Book of Order reminds us that "Presbyters are not simply to reflect the will of the people, but rather to seek together to find and represent the will of Christ." (F-3.0204)
- A meeting of Presbytery is a deliberative body open to the give-and-take of discussion and to the free working of the Holy Spirit.

#### FOR YOUR INFORMATION

#### From Stewardship & Finance Ministry Team

- Bethelwoods 2023 Year-End Shortfall: As of November 30<sup>th</sup> Bethelwoods, was experiencing a shortfall of -\$75,105.36. Shortfall is mainly due to resident camps not meeting budget due to economic conditions. Summer program resident camp income was \$146,750.83 and was budgeted to be \$197,665.00 shortfall of -\$50,914.17. The shortfall here was in overnight camps. They've also had approximately \$19,300.00 in unanticipated expenses with maintenance of camp. As of 11/30/23 a total of \$22,823.52 in Bethelwoods designated accounts will be used to help cover this shortfall. The designated accounts are Online Donations and Annual Fund donations. Realizing that Bethelwoods is a ministry of Providence Presbytery we are responsible to cover any remaining budget shortfalls.
- 2. **Bethelwoods Update**: Bethelwoods board begins 2024 with a retreat week-end in January to continue working towards becoming an independent 501C3. The Stewardship & Finance team along with others are working on a land agreement between Providence and Bethelwoods that is part of this process. The hope is to complete this process in 2024.
- Year-End Financial Report: not available at handbook deadline will be added to handbook when it's completed. As of 1/22/24 we still have churches that have not completed pledges for 2023 and churches that have not returned their 2024 Mission Partnership form. There will be an appendix report listing outstanding churches for both 2023 and 2024. (See Appendix 4: Pages 3 – 7)

# Partnership with Serving at the Crossroad / Manos Amigas Clinic, Municipality of Trinidad, and the Presbytery's Eye Clinic Project

Manos Amigas was started about 20 years ago by a group of Presbyterians in Pennsylvania and New Jersey. We have had many conversations with Mike Tysowsky, the Chairman of the Board of Serving at the Crossroad [SATC]. Manos Amigas is registered with the Honduran government. At first, the clinic provided general medical care. Over the years dental and eye care have been added. There are now three



rooms for eye surgery. Most of the staff at Manos Amigas are Hondurans. Teams of doctors from the US come during the year. Usually a group of ophthalmologists come three times a year to do eye surgery. **SATC website:** <u>https://www.servingatthecrossroads.org</u>

The optometrist on the staff at Manos Amigas will go to Trinidad once a month to examine eyes in the eye clinic there. Those individuals identified as needing cataract surgery will be referred to Manos Amigas where visiting ophthalmologists will do the surgery. Funds provided by Providence Presbytery's "New Vision for Honduras" will pay for the optometrist's time and transportation to and from Trinidad.



A team of ophthalmologists was at Manos Amigas Clinic in January. They performed eye surgeries for more than 80 individuals. Four of those scheduled for surgery were from the Municipality of Trinidad. A team from Wake Forest Medical School faculty is scheduled to do cataract surgeries in May. Funds from "New Vision for Honduras" will pay for the cataract surgery for those from the Municipality of Trinidad who need assistance.

We are grateful to the individuals, families, and churches that have contributed to "New Vision in Honduras" since 2014. We have sent the balance of donated funds, \$27,093.25, to Serving at the Crossroad for a designated account to pay for expenses related to identification of cataracts and cataract surgery for residents of the Municipality of Trinidad. SATC will send us quarterly reports about the services provided and the amount used from the fund designated to help those from the Municipality of Trinidad.

We will contact donors to "New Vision in Honduras" and encourage them to continue to support this mission by giving through Serving at the Crossroads, a 501C3 organization. We will ask SATC to note that donations from within the area of Providence Presbytery be designated for fees related to examinations and cataract surgeries for residents of the Municipality of Trinidad so that our original plan may continue.
