Inquirer Jackson Ringley Statement of Faith

I believe in God the Father, the one who never ceases to create. Having drawn all things from no-thing, God breathes life into all that is, from person to plankton to molecule, animating the world with God's own wonder, curiosity, creativity, and joy. Like an artist, God made humankind out of God's own playful desire to create, and God continues to desire a relationship with the creation, even though we humans fail to live up to God's call for love, peace, faithfulness, and justice. God asks that all people live out this relationship in word and in deed, inviting each believer to proclaim the faith with one's very life. We do so imperfectly, but God chooses us anyway. Even amid our inevitable shortcomings, God is ever faithful, for this is the God who *never lets go*. God is moving, dreaming, and hoping alongside us in every moment of every day, striving with us for the new creation, when every tear shall be wiped from our eyes.

I believe in Jesus the Christ, God-incarnate, the Son of the Father, the Messiah, the Savior. God freely enfleshed Godself within God's own creation, living and dying as humans do, seeking to teach us new ways to live out faith. Jesus, the master storyteller, revealed to his disciples with illustrative flair what the world *could* be, even when that world seemed impossible.

Xiv We live in the aftermath of Resurrection, knowing that more life is always possible, and waiting for Christ, the anointed one, to come again. Xv

I believe in God the Holy Spirit, the one who stirs our hearts and minds, inviting us to witness for ourselves the work of the divine. The Spirit animates the Holy Scriptures of the Bible, drawing us into the ongoing revelation of God in every age through the sharing of stories, letters, songs, Gospels, prophecies, and more. At his baptism, the Spirit descended on Jesus like a dove, blessing him with the promise of life. The Spirit unites all believers in that promise still, for Christians in every time and place have been moved by the Spirit who brings the love, hope, and wisdom of God throughout the world. As in ancient times and modern ones, the Spirit stirs the souls of prophets, apostles, preachers, and parishioners, providing gifts for the service of God's dominion here on earth. The Spirit compels us to be change-makers for God's vision of peace, joy, and justice, supplying strength for life with God and with one another in a broken world.

Community of Love Coordinating Team Report May 5, 2024

Items for Information:

1. Administrative Commissions (AC)

- a. Mt. Tabor (U) Presbyterian Church This AC has remained in diligent communication with the church session. The Mt. Tabor (U) session indicates that they have contacted and applied to another denomination for membership, though correspondence with that denomination does not agree with that assertion. The session's contact with the AC has waned. The AC sent a letter indicating that the session needs to send evidence that they have at least applied for membership to the other denomination by August 31, 2024 or the AC would take actions towards the termination of this separation process.
- b. Oakdale Presbyterian Church A covenant was reached between the AC and the Oakdale session regarding terms for transferring their membership. See action item #1 below. (See Pages E: 4 5).
- c. Cedar Shoals Presbyterian Church and Fort Lawn Presbyterian Church The ministry of these two congregations is complete, and the AC continues to work with them to close their respective churches.
- d. **Bethesda (K) Presbyterian Church** The AC has met for training and has had several communications with the Discernment Team who is leading Bethesda (K) through this process. Progress is being made.

2. Session Minutes Review and Evaluation

We approved the following motion regarding Clerk of Session records: (1) that John Nettles, Ronnie Bailes and Cathy Phillips serve as moderators of that team and that (2) we approve the plan and schedule as provided. (See Pages E: 6 - 7)

3. Presbytery Fellowship Events

In past years, Presbytery staff has served as the organizing force for several important events for the Presbytery, including the Legacy of Faith Awards Luncheon, Pastors Appreciation Luncheon, and Administrative Assistant Luncheon. With the transition in Presbytery staffing leading to reduced working hours for almost every staff position, the Presbytery staff can no longer do so. After discussing possibilities, the idea arose to introduce these events to Presbytery as an opportunity for a neighborhood of interested and dedicated folks to arise to organize these events. Eric Robinson agreed to broach this idea at the May 5, 2024 Presbytery meeting.

4. Executive Presbyter Search Team

It has been announced that, due to health concerns and through circumstances beyond anyone's control, the team searching for the next installed EP was disbanded without being able to bring a name to place in nomination. This team worked well together and are to be commended. Discussions began about forming another EP search team, and names for folks to serve were discussed and some phone calls are being made. In the meantime, with Rev. Dr. Toby Mueller having stepped down from the bridge EP role to accept a call in Gastonia, the Administrative Team has offered, and the Community of Love has approved, a bridge EP search team of Rev. Dr. Jeff Bryan, Linda Kennedy and Rev. Edgar McCall.

5. Churches Selling Property

The Great Falls Presbyterian Church and the Covenant Presbyterian Church are in the process of selling a portion of their church properties. In the 1980's, each congregation signed a property exemption document that includes this language: "Nothing in this chapter shall be construed to require a particular church to seek or obtain the consent or approval of any church court above the level of the particular church in order to buy, sell or mortgage property of that particular church in the conduct of its affairs as a church in the PCUS." Therefore, approval from Presbytery is not required for these transactions.

6. General Assembly (GA) Young Adult Advisory Delegate

Because of an unforeseen scheduling conflict, Will Shillington will be unable to serve as Providence Presbytery's Young Adult Advisory Delegate at the 2024 meeting of the General Assembly. The Nominations and Representation team reports that Meredith Welfare of the Unity Presbyterian Church will serve in that capacity.

Items for Action:

1. Administrative Commission for Oakdale Presbyterian Church

"The Administrative Commission for Oakdale Presbyterian Church moves that Providence Presbytery transfer the membership of the Oakdale Presbyterian Church (USA) congregation to the Covenant Order of Evangelical Presbyterians according to the terms of the attached Covenant agreement, said agreement having been unanimously approved by the Oakdale congregation at an April 14, 2024 congregational meeting." (See Pages E: 4 - 5)

2. Oakland Avenue Presbyterian Church Mortgage

The Community of Love moves that Presbytery:

- (1) approve the request of the Oakland Avenue Presbyterian Church to mortgage their property at 421 Oakland Avenue, Rock Hill, SC according to the terms of the loan application. (See Pages E: 8 14)
- (2) that, as required for loans from the Presbyterian Investment and Loan Program (PILP), Providence Presbytery approve and authorize the Stated Clerk to sign all documents necessary for the Presbytery to act as a guarantor of this loan.

3. Bills and Overtures

The Presbytery received three overtures to the General Assembly in time for the Providence Presbytery Bills and Overtures team, created by the Coordinating team for this purpose, to meet and consider whether to concur with the overtures offered and approved by three different Presbyteries. (See Pages E: 15 - 23)

The team recommends Presbytery to non-concur with the following overture:

A. Overture to Require that Administrative Leave under D-7.0902 be Paid Leave. (See Pages E: 17 - 19 of the Bills & Overtures Committee Report)

The team recommends Presbytery concurs with the following overtures:

- B. The Presbytery of Greater Atlanta overtures the 226th General Assembly (See Page E: 20 of the Bills & Overtures Committee Report)
- C. Overture to the 226th General Assembly (2024) On the development of educational resources for faith formation for congregational use and to meet the needs of the small church (See Pages E: 21 23 of the Bills & Overtures Committee Report)

Covenant Agreement between Oakdale Presbyterian Church and Providence Presbytery regarding

Terms of Dismissal from the Presbyterian Church (USA) to the Covenant Order of Evangelical Presbyterians

- 1. Providence Presbytery of the Presbyterian Church (USA) (which may be referred to hereinafter as "Presbytery") recognizes the desire of the Oakdale Presbyterian Church (which may be referred to hereinafter as "Oakdale") to be dismissed to the Covenant Order of Evangelical Presbyterians. Providence Presbytery is represented in this matter by an Administrative Commission duly elected by Providence Presbytery.
- 2. The Administrative Commission recommends that the congregation be dismissed to the Covenant Order of Evangelical Presbyterians with the Church property pending the vote of the Oakdale congregation and the vote of Presbytery at duly called meetings (both votes to be taken in accordance with the provisions of the PC(USA) Book of Order and their respective by-laws and/or manuals of operation) once the following conditions have been met:
 - a. Providence Presbytery and Oakdale agree through these terms to support the continued ministry of one another. Oakdale agrees to support the ministry of Providence Presbytery with a ministry support contribution of \$73,000, which represents the following:
 - i. \$68,000 to support the Presbytery's future ministries.
 - ii. \$5,000 for per capita giving.
 - iii. Total support: \$73,000 (determined by adding the two items above)
 - i. This amount to be paid in full upon the entering of this covenant and approval by the Oakdale congregation and Presbytery.
 - ii. All of Oakdale's obligations, including financial obligations, will be met before Presbytery dismisses them to the Covenant Order of Evangelical Presbyterians and before Presbytery executes the quit claim deed referenced in section c below.
 - b. After the financial terms are met and, by its favorable vote, Presbytery formally dismisses Oakdale Presbyterian Church to the Covenant Order of Evangelical Presbyterians, neither the church nor the Presbytery will have any legal or ecclesiastical responsibilities or obligations to one another. Providence Presbytery will cease to have any claim to (other than as otherwise set out in this document) or responsibility for the use, maintenance and ownership of the Oakdale church property, which includes all land, improvements, buildings and cemetery holdings located at 12585 West Hwy. 55, Clover, SC 29710.
 - c. After the financial terms are met and the congregation has been received into the Covenant Order of Evangelical Presbyterians and established as Oakdale Presbyterian Church (ECO), Providence Presbytery will support the continuing mission of Oakdale by executing a quit claim (non-warranty) deed to Oakdale Presbyterian Church (ECO)

- establishing that the Presbytery no longer has any trusteeship over, ownership of or legal or ecclesiastical responsibility related to the property referred to in paragraph 2b above and the use thereof.
- d. Oakdale will pay all the legal fees and filing fees to their choice of a competent real estate attorney licensed in South Carolina in connection with the creation of the quit claim (non-warranty) deed referred to in section 2c above and, after the execution of said document by the Presbytery, filing it with the York County Register of Deeds. Oakdale shall mail to the Executive Presbyter or Stated Clerk of Providence Presbytery a copy of said deed after it is filed with the York County Register of Deeds.
- e. Oakdale covenants its intent to continue to use the property conveyed in the deed referred to above in sections 2c and 2d for church and/or other Christian related purposes.
- f. Upon approval of these terms of dismissal by Oakdale and Providence Presbytery, Providence Presbytery will no longer list Oakdale as one of her member churches for any purposes. Oakdale will no longer use, utilize or display the denominational name "Presbyterian Church (USA)" or the acronyms "PCUSA" and "PC(USA)," nor will it include or display "USA" or "(USA)" as a part of its church name, nor will it use, utilize or display the name "Providence Presbytery." Oakdale will also no longer use, utilize or display the seal of the Presbyterian Church (USA), sometimes called her logo.
- g. If either Oakdale or Presbytery fails to approve this covenant and accept its terms, then negotiations will resume about terms of dismissal.

Bills and Overtures Committee of Providence Presbytery Recommendations for Overtures to the 226th General Assembly (2024) To Providence Presbytery May 5, 2024

The Bills and Overtures Committee of Providence Presbytery met to discuss three overtures being presented to the GA from neighboring presbyteries—our recommendations of Concurrence or Non-Concurrence for Providence Presbytery with short explanations to follow:

A. Overture to Require that Administrative Leave under D-7.0902 be Paid Leave (See Pages E: 17 - 19)

The Presbytery of Charleston Atlantic overtures the 226th General Assembly (2024) of the Presbyterian Church (U.S.A.) to direct the Stated Clerk to send the following proposed amendment to the Presbyteries for their affirmative or negative vote.

1. Shall Section D-7.0902.b., regarding administrative leave, be amended as follows: [Text to be added is shown in bold italics.]

Regardless of the employment status of the Minister of Word and Sacrament, the members designated in accordance with D-3.0102, shall determine as quickly as possible, after receiving the written allegations and providing the accused an opportunity to be heard, whether the risk to a congregation and/or to other potential victims of abuse requires **paid** administrative leave or other restrictions upon the minister's service when considered in light of the nature and probable truth of the allegations. Such **paid** administrative leave or restrictions will continue until either the matter is resolved in one of the ways prescribed in the disciplinary process or until the leave or restrictions are altered or removed by members of the commission. The cost shall be borne by the employing entity whenever possible or be shared by the presbytery as necessary.

Recommendation from the B&O Committee: Non-Concurrence

Rationale: The committee reached out to the chair of the original GA committee to inquire why the language did not mandate paid leave. According to the response received, the committee believed that each Presbytery should determine what would work best for their member churches. Keeping this in mind, the B&O committee agrees that many of our member churches would not be able to afford pulpit supplies while a pastor is on paid administrative leave. Furthermore, the presbytery would need to have funds available to cover the cost.

- B. The Presbytery of Greater Atlanta overtures the 226th General Assembly (2024) to direct the Stated Clerk to send the following proposed amendment to the presbyteries for their affirmative or negative votes: (See Pages E: 20)
- 1. Shall G-2.0610 be amended as follows: (text to be deleted is struck through) When a presbytery concludes there are good and sufficient reasons for accommodations to the particular circumstances of an individual seeking ordination, it may, by a three-fourths vote, waive any of the requirements for ordination in G-2.06, except for those of G-2.0607d. If a presbytery judges that there are good and sufficient reasons why a candidate should not be required to satisfy the requirements of G-2.0607d, it shall approve by three-fourths

vote some alternate means by which to ascertain the readiness of the candidate for ministry in the areas covered by the standard ordination examinations. A full account of the reasons for any waiver or alternate means to ascertain readiness shall be included in the minutes of the presbytery and communicated to the presbytery to which an inquirer or candidate may be transferred.

Recommendation from the B&O Committee: Concurrence

Rationale: The Committee on Preparation for Ministry (CPM) of Providence Presbytery is well-equipped to guide and evaluate candidates for ministry. As such, the presbytery should trust the CPM's assessment and recommendation of a candidate, regardless of whether the candidate is neurodivergent or has other abilities. Other Presbyteries should also trust their CPM in all matters concerning candidates. Therefore, including a "full account of the reasons" for a candidate's faith journey in the minutes of the examining presbytery may cause unnecessary distress when the candidate's achievements should be celebrated, not stigmatized.

- C. OVERTURE TO THE 226TH GENERAL ASSEMBLY (2024) On [the] development of educational resources for faith formation for congregational use and to meet the needs of the small church. (See Pages E: 21 23)
- 1. The Presbytery of Riverside overtures the 226th General Assembly (2024) to direct the Presbyterian Mission Agency's Office of Christian Formation (and/or their successor entities) and the Presbyterian Publishing Corporation, in collaboration with Research Services, to study and formulate a plan for the future development of educational resources for faith formation and nurture especially for congregational use. Research should be qualitative, including methods such as focus groups and interviews with practitioners. Relying on this and pertinent prior research, collaborators shall pay particular attention to affordability and the needs of the small church. The Office of Christian Formation and the Presbyterian Publishing Corporation shall bring a concrete proposal regarding funding, staffing, and implementation to the [GA] (2026).

Recommendation from the B&O Committee: Concurrence

Rationale: The committee firmly believes that education forms the bedrock of our spiritual path. As Presbyterians, we have always been committed to education, especially for our younger generation. It's not a secret that most of the churches in PC(USA) are smaller in size. Therefore, this proposal aims to provide affordable educational resources that will help us preserve and promote our reformed traditions.

These are the recommendations humbly submitted after prayerful and studied consideration to Providence Presbytery by the Bills and Overtures committee. Thank you, and may the Spirit continue to bless the Church in the world by the work of God's hands.

Overture to Require that Administrative Leave under D-7.0902 be Paid Leave

The Presbytery of Charleston Atlantic overtures the 226th General Assembly (2024) of the Presbyterian Church (U.S.A.) to direct the Stated Clerk to send the following proposed amendment to the presbyteries for their affirmative or negative vote.

1. Shall Section D-7.0902.b., regarding administrative leave, be amended as follows: [Text to be added is shown in bold italics.]

Regardless of the employment status of the Minister of Word and Sacrament, the members designated in accordance with D-3.0102, shall determine as quickly as possible, after receiving the written allegations and providing the accused an opportunity to be heard, whether the risk to a congregation and/or to other potential victims of abuse requires paid administrative leave or other restrictions upon the minister's service when considered in light of the nature and probable truth of the allegations. Such paid administrative leave or restrictions will continue until either the matter is resolved in one of the ways prescribed in the disciplinary process or until the leave or restrictions are altered or removed by members of the commission. The cost shall be borne by the employing entity whenever possible or be shared by the presbytery as necessary.

Rationale:

This amendment would preserve the due process rights of all ministers of the Word and Sacrament accused of sexual misconduct without diminishing the protections afforded to the alleged or potential victims of that misconduct.

Since the imposition of administrative leave was first authorized on July 3, 2005, until the adoption of Church Discipline on July 9, 2023, all ministers and presbyteries throughout the denomination were subject to a single, standard process when allegations of sexual misconduct were received. That process — standard throughout the denomination — provided presbyteries the necessary mechanism for imposing administrative leave while requiring that the leave be paid.

The imprecision and ambiguity of the current language in D-7.0902 fails to provide a standard process applicable throughout the denomination. The text of D-7.0902 fails to define the administrative leave as either paid or unpaid. The conspicuous omission or deletion of "paid administrative leave" from the text of D-10.0106 in the Rules of Discipline, and the substitution of simply "administrative leave" in D-7.0902 in Church Discipline lead to at least two plausible interpretations: first, that all administrative leave is to be unpaid, and second, that each presbytery can set its own policy as to whether the leave is to be paid or unpaid. Such imprecision

and ambiguity do not provide an acceptable constitutional standard to be applied equally to all ministers of the Word and Sacrament.

I. Unpaid Administrative Leave is Improper. If the drafters' intent was that all administrative leave is to be unpaid, that result unfairly and improperly deprives ministers of the Word and Sacrament of vital due process protections.

A.Unpaid Leave Undercuts the Presumption of Innocence. The imposition of unpaid administrative leave within days of receipt of allegations, before even an investigative committee has been appointed, is completely inconsistent with and dramatically undercuts the presumption of innocence set forth in D-8.0201.c. Not only is a minister stripped of all ecclesiastical authority, but the presbytery immediately deprives the minister of any right to compensation as set forth in the terms of call to which the minister and congregation have agreed and which the presbytery approved.

B. Diminished Standard of Proof. The current language in D-7.0902.b. allows the forfeiture of all compensation based upon a demonstrably lower standard of proof than that required for an ultimate finding of guilt. D-7.0902.b. allows the imposition of administrative leave based on the "probable truth of the allegations." D-8.0902 allows a finding of guilt only "when a comparison and consideration of all the evidence compels an abiding conviction that the material facts necessary to prove the charge are true." Relying on phraseology from the Rules of Discipline, those standards of proof would have been probable cause and beyond reasonable doubt. Regardless of the phraseology incorporated into Church Discipline, the quantum of proof required under D-7.0902.b. is dramatically less than that in D-8.0902.

C. Pretrial Forfeiture of Compensation is Punitive. "[T]he exercise of church discipline is one for building up the body of Christ, not for destroying it, for redeeming, not for punishing. "D-1.01 (Emphasis added). The forfeiture of all compensation within days of receipt of allegations, before an investigation or trial, is tantamount to punishment before an adjudication of guilt and is contrary to the constitutional objectives.

II. Constitutional Due Process Must Have Consistent Application.

The Presbyterian Church (U.S.A.) has long been committed to equal protection of all persons. The Foundations of Presbyterian Polity proclaim that commitment: "The Presbyterian Church (U.S.A.) shall guarantee full participation and representation in its worship, governance, and emerging life to all persons or groups within its membership." F-1.0403. The 225th General Assembly implemented that guarantee when it chose to require the inclusion of a specified amount of family leave for all installed pastors rather than allowing each presbytery to adopt its own policy. G-2.0804. The 226th General Assembly should provide a similar denomination-wide requirement for administrative leave.

The provisions of Church Discipline apply throughout the denomination to afford all involved equal protection and equal access. "The Constitution of the Presbyterian Church (U.S.A.) is infused with principles and standards to which all active members of congregations and ministers of the Word and Sacrament voluntarily submit." D-1.0201 (Emphasis added).

Individual presbyteries cannot establish their own quorum requirements for their permanent judicial commissions. D-3.0602. Individual presbyteries cannot establish their own time periods for filing a notice of appeal. D-10.0201. Individual presbyteries cannot establish their own criteria for the composition of the special committee authorized to determine the necessity of administrative leave. D-3.0102. Each of these and other judicial processes have been established by the Constitution of the Presbyterian Church (U.S.A.) for equal application throughout the denomination. Why then should the issue of compensation during administrative leave be left to individual presbyteries to determine?

The right of a minister of the Word and Sacrament to be informed of a pending disciplinary process does not depend on the rules of the presbytery to which the minister belongs. D-7.0501. The right of a minister of the Word and Sacrament to be presumed innocent does not depend on the rules of the presbytery to which the minister belongs. D-8.0201.c. The right of a minister of the Word and Sacrament to be represented by counsel does not depend on the rules of the presbytery to which the minister belongs. D-7.1003.c. and D-8.0103.d.(2). Each of these and other rights have been established by the Constitution of the Presbyterian Church (U.S.A.) for equal application throughout the denomination. Why then should the entitlement of a minister of the Word and Sacrament to compensation while on administrative leave depend on the rules of the presbytery of the minister's membership?

The full participation in the governance of our church, guaranteed in F-1.0403, demands that the provisions of Church Discipline be enforced and implemented equally throughout the denomination. The current text of D-7.0902 does not meet that constitutional guarantee.

Conclusion:

For the foregoing reasons, the provisions of D-7.0902 should be amended to require paid administrative leave as set forth in the proposed overture.

The Presbytery of Greater Atlanta Overture to the 226th General Assembly (2024)

I attest that the Presbytery of Greater Atlanta approved the following overture at its Fall Stated Meetigng on November 4, 2023.

Rev. C. Anderson James Stated Clerk

The Presbytery of Greater Atlanta overtures the 226th General Assembly (2024) to direct the Stated Clerk to send the following proposed amendment to the presbyteries for their affirmative or negative votes:

Shall G-2.0610 be amended as follows: (text to be deleted is struck through)

When a presbytery concludes there are good and sufficient reasons for accommodations to the particular circumstances of an individual seeking ordination, it may, by a three-fourths vote, waive any of the requirements for ordination in G-2.06, except for those of G-2.0607d. If a presbytery judges that there are good and sufficient reasons why a candidate should not be required to satisfy the requirements of G-2.0607d, it shall approve by three-fourths vote some alternate means by which to ascertain the readiness of the candidate for ministry in the areas covered by the standard ordination examinations. A full account of the reasons for any waiver or alternate means to ascertain readiness shall be included in the minutes of the presbytery and communicated to the presbytery to which an inquirer or candidate may be transferred.

Rationale

Those persons who respond to the call to serve as a minister of the Word and Sacrament in the church have embarked on a sacred journey, accompanied by their home congregation and presbytery of care. Along the way, the presbytery and the inquirer or candidate develop a relationship of accountability and trust that enables and empowers the whole church to be a part of this journey of faithful response to God's call. Placing a detailed record of a potentially traumatic encounter in the permanent records of the presbytery does little to further this relationship of accountability and trust and only provides an opportunity to increase and intensify harm.

Removing this requirement for this full account of the reasons for a waiver of examination requirements for those under the care of a presbytery clarifies that the detailed record of a person's preparation for ministry process is independent from the long-term story of that person's faithful service as a minister. This amendment simplifies the text of the Constitution by making it less of a manual of operations and gives voice to emerging understandings of learning differences, cultural competency, and neurodivergence that are increasingly common within and beyond the church. The proposed amendment allows for greater pastoral sensitivity by presbyteries in their care of those preparing for ministry and encourages presbyteries to trust one another in their work with those preparing for this sacred calling.

The Presbytery of Riverside OVERTURE TO THE 226TH GENERAL ASSEMBLY (2024)

On development of educational resources for faith formation for congregational use and to meet the needs of the small church

Recommendation

The Presbytery of Riverside overtures the 226th General Assembly (2024) to direct the Presbyterian Mission Agency's Office of Christian Formation (and/or their successor entities) and the Presbyterian Publishing Corporation, in collaboration with Research Services, to study and formulate a plan for the future development of educational resources for faith formation and nurture especially for congregational use. Research should be qualitative, including methods such as focus groups and interviews with practitioners. Relying on this and pertinent prior research, collaborators shall pay particular attention to affordability and the needs of the small church. The Office of Christian Formation and the Presbyterian Publishing Corporation shall bring a concrete proposal regarding funding, staffing, and implementation to the 227th General Assembly (2026).

Rationale

On March 1, 2018, the responsibility for the publication of educational curricula was moved from the Presbyterian Mission Agency (PMA) to the Presbyterian Publishing Corporation (PPC), a separate business. In the fall of 2023, the Presbyterian Publishing Corporation announced that it would pause the creation of new English-language all-age curriculum products, due to the great cost of developing and publishing these materials. We understand that many denominational publishing houses are challenged by the cost of producing congregational resources. We are delighted that Korean and Spanish resources will continue to be newly published thanks to funding from the denomination. Current English-language curriculum materials will cover the next three years, but no new materials are in development.

The Presbyterian Church has a proud heritage of producing outstanding educational resources and is still continuing that tradition with a robust emphasis on materials for home and family life. However, a gap is developing in materials for use by congregations – a gap that will become too large if not addressed in a timely manner. The future of this denomination rests on raising children and nurturing adults rooted in the richness of the Reformed understanding of the Christian faith. Addressing this problem will require conversations and joint planning between the Office of Faith Formation and the Presbyterian Publishing Corporation.

Reformed theology mandates providing for faith formation, nurture, and education of church members, grounded in the Reformed understanding of the sacrament of baptism:

- W-3.0403: "The congregation as a whole, on behalf of the universal Church, is responsible for nurturing baptized persons in Christian life."
- W-4.0201: "It is the responsibility of the whole congregation, particularly exercised through the Session, to nurture those who are baptized as they grow in faith and seek to respond to Christ's call to discipleship."

- W-5.0203 "God calls the Church to continue the teaching ministry of Jesus Christ, guiding and nurturing one another through all the seasons and transitions of life. In particular, the church offers opportunities for education and formation as members enter the community of faith, discover Christian vocation, and assume responsibility in the world."
- W-5.01 W-5.0203-W-5.0204: "The educational ministries of the church are rooted in the promises of Baptism, in which the congregation pledges responsibility for Christian nurture."

A Reformed theology of the mission of Christ's church also guides us:

- F-1.0304: "The great ends of the Church are:
 ... the proclamation of the gospel for the salvation of humankind; the shelter, nurture,
 and spiritual fellowship of the children of God....; the preservation of the truth...."
- G-1.0101: "In the life of the congregation, individual believers are equipped for the ministry of witness to the love and grace of God in and for the world."
- G-3.0201: ".... the Session has responsibility and power to:
 a. provide that the Word of God may be truly preached and heard. This responsibility shall include providing a place where the congregation may regularly gather for worship, education, and spiritual nurture...." The same responsibilities are given to presbyteries, synods and the General Assembly (G-3.0301a; G.0401; G-3.0501a)

Actions of past General Assemblies confirm the need for continuing the development of educational resources for congregations, based in the Reformed tradition.

- Final Report of the Workgroup on the Role and Status of Christian Educators in the PC(USA): GA Minutes 2000, Part 1. P.199.
 "The Presbyterian Church (U.S.A.) emphasizes the education of the people of God as a primary task of the church. Through dynamic inter-action persons and communities are challenged to form a faith perspective through which they view the world and acknowledge the active presence of God. Intentional Christian education provides a variety of opportunities for people of all ages to explore the elements of the Christian story, reflect on their experiences in the light of Scripture, and respond through action in the world."
- GA 2018: "The General Assembly's Special Committee to Study the Reformed Perspective of Christian Education in the 21st Century recommends that the 223rd General Assembly (2018) do the following:
 - "1. Encourage the Presbyterian Mission Agency (PMA) to adjust to a shift in Christian education paradigms and practices over the last several decades and therefore
 - "a. support the restructuring, resourcing, and staffing of the ministry area of Christian formation, working to—continue resourcing age and stage Christian education, while transitioning to an emphasis on lifelong Christian education and faith formation, especially intergenerational ministry;

- "b. encourage the newly structured ministry area of Christian Formation to dedicate resources to be focused on supporting local congregations (facilitating the networking, coaching, and training of local leaders).
- "2. Direct that curriculum and/or resources produced by the Presbyterian Publishing Corporation and Geneva Press [now Westminster John Knox Press] shall be in consultation and collaboration with the ministry area[s] of Christian Formation [and Racial Ethnic and Women's Ministries] of the Presbyterian Mission Agency."
- GA 2018: The Matthew 25 Initiative: The first mark of Congregational Vitality is
 "A commitment to forming disciples over every member's lifetime. This leads first to
 personal transformation, as people put on the heart of Christ, and then to social
 transformation, as people joyfully go forth into the community and tackle the issues
 facing today's culture. "

• GA 2022:

- "1. Direct the Presbyterian Mission Agency (PMA) to create a PMA associate position (1.0 FTE) to equip and connect Christian formation practitioners across the denomination (professional educators, pastors, volunteers, commissioned ruling elders [CREs], etc.). Responsibilities will initially include... identifying gaps in resources available and finding ways to help fill them; assisting those involved in planning of Christian education with suggestions, resources, and training for ministry; making connections between Christian formation leaders across the denomination.
- "2. Direct Research Services, in the Administrative Services Group, to conduct a qualitative research study exploring the particularities and differences of Christian education and faith formation ministries and practices in racial ethnic minority congregations, for the purpose of informing the Presbyterian Mission Agency (PMA) offices related to Christian formation, as well as the cultural sensitivity and relevance for Presbyterian Publishing Corporation (PPC) publications. These offices should report back to the 226th General Assembly (2024) as to how this information was disseminated and implemented."

In his provocative book, Will Our Children Have Faith? John Westerhoff stated that it only takes one generation for the world to lose the Christian faith. As members of the Presbyterian Church (USA) we are committed to ensuring that the richness of our branch of the Christian faith continues for the next generation. We believe that this overture creates a step in that direction.

For Action:

1. The Community of Faith, acting through the Presbyterian Women (having been tasked to create a Presbytery Disaster Assistance Commission and description of the Presbytery Team Coordinator), moves the approval of the creation of the Presbytery Disaster Assistance Commission and the position of Presbytery Team Coordinator (See Pages F: 3 - 6). Said Commission and document was approved by the Providence Presbyterian Women on April 13, 2024 and by the Community of Faith on April 16, 2024.

Presbytery Team Coordinator (PTC)

<u>PURPOSE</u>: The Presbytery Team Coordinator (PTC) shall serve as a primary resource at the Presbytery level, under the supervision of the Presbytery Disaster Assistance Commission (PDAC), for the purpose of assisting the PDAC in communicating with the congregations through the church's Disaster Preparedness Contact (DPC). They shall communicate information relevant to the organization of congregational preparation, mitigating response and recovery before, during, and after a disaster, whether naturally or humanly caused. In coordination with the PDAC, the PTC will also develop relationships with neighboring presbyteries and support them when possible in times of disaster.

ACCOUNTABILITY: The Presbytery Team Coordinator (PTC) shall be accountable to the Presbytery Disaster Assistance Commission (PDAC). The PDAC shall be accountable to the Presbytery through the Council.

RESPONSIBILITIES:

- 1. Coordinate with the PDAC to seek a Disaster Preparedness Contact (DPC) for each church.
- 2. Have current knowledge of the congregations within the Presbytery, their leadership, addresses, email addresses, and phone numbers.
- 3. Be thoroughly familiar with the infrastructure of the Presbytery, including roads, emergency shelters, emergency management contact information, etc.
- Be knowledgeable to the roles and responsibilities of local organizations active in disaster (local government, Salvation Army, local Emergency Management, and VOADs).
- 5. Participate in disaster response training provided by PDA or the Synod and be prepared to share that training with the PDAC and the churches DPC.
- 6. Disseminate information from the PDAC about disaster preparedness resources from the Synod, Presbyterian Church (U.S.A), and other agencies with the church DPC, as appropriate.
- 7. When assigned by the PDAC, work in partnership with local and denominational agencies.
- 8. Assist the PDAC in preparing and sending quarterly Public Service Announcements (PSA) to churches.
- 9. Be a member of the PDAC.
- 10. Be a member of the South Carolina Presbyterian Disaster Assistance Team (SC PDAT).

TERM: The Presbytery Team Coordinator (PTC) is appointed by the Presbytery Disaster Assistance Commission (PDAC) and will serve on a yearly basis, . There will be no specific limitations on renewals.

The PTC is to work in concert within the governance of the Presbytery Disaster Assistance Commission of the Presbytery.

DPC – Disaster Preparedness Contact for churches

PTC – Presbytery Team Coordinator

PDAC – Presbytery Disaster Assistance Commission

VOAD – Volunteer Organizations Active in Disasters

PRESBYTERY DISASTER ASSISTANCE COMMISSION

Purpose: The purpose of the **Presbytery Disaster Assistance Commission** (PDAC) is to direct and oversee the preparation for and response to a disaster on behalf of Providence Presbytery in order to focus, align, and coordinate resources toward areas of need.

Accountability: The PDAC shall be accountable to Providence Presbytery through the Community of Love (CT).

Authority: The PDAC may act in times of disaster on behalf of and with the full authority of Providence Presbytery between meetings of Providence Presbytery, in any and all matters, except those responsibilities given to the Constitutional committees (Committee on Ministry, Preparation for Ministry, Committee on Representation and Nominations, and Permanent Judicial Commission) and any other special Providence Presbytery commissions.

Membership: The PDAC shall consist of Thirteen (13) members:

- Providence Presbytery Moderator, General Presbyter, Presbyterian Women Moderator/Co Moderator, and Stated Clerk (4).
- Nine (9) at-large members nominated by the Coordinating Team and elected by Providence Presbytery who have experience/knowledge in the area of disaster preparedness, relief and assistance, emergency management, construction and/or emergency medical response.

The commission shall select one of its own to moderate/co-moderate the PDAC and a Clerk shall record and distribute minutes. In the absence of the selected moderator, the Providence Presbytery Moderator/Co Moderator will moderate.

Overall composition shall strive to conform to principles of inclusiveness, representation and participation for race and gender, as well as the following principles:

• No more than one member shall be a member of or serving a particular congregation unless needed for a particular reason.

Quorum: A quorum of the PDAC shall consist of a majority of its membership and shall be required for business to be conducted and action taken.

Meetings: As needed, but at least quarterly for organizing, preparedness work and coordination.

Responsibilities:

- 1. Assist congregations of Providence Presbytery and their members with disaster preparedness and in times of disaster, including by not limited to authorizing grants and disbursements of appropriate funds.
- 2. Coordinate all communication between the Providence Presbytery congregations, Providence Presbytery, Synod of South Atlantic, and the Presbyterian Church (U.S.A.), including the Presbyterian Disaster Assistance (PDA), as well as any other appropriate agencies.

- 3. Assign a member of the commission to represent Providence Presbytery on the SC VOAD (South Carolina Voluntary Organizations Active in Disaster).
- 4. Assess the damage and evaluate the needs of Providence Presbytery congregations and their members.
- 5. Acquire and coordinate, as appropriate, resources from the Synod of South Atlantic and the Presbyterian Church (U.S.A.) as well as any other appropriate agencies.
- 6. Work in partnership with local and denominational agencies when appropriate.
- 7. Communicate with the Providence Presbytery Community of Love (CT) and Providence Presbytery all work and action taken, providing an annual written report to both.
- 8. Communicate to the Community of Love (CT) when a member of the PDAC needs to be replaced.
- 9. Team will evaluate each year who needs to be replaced.

HELPFUL HINTS FOR PRESBYTERY COMMISSIONERS

Congratulations on being chosen to be a commissioner to this Presbytery meeting from your congregation! Below are some thoughts and observations that you may find helpful as you prayerfully prepare to fulfill your responsibility.

- Our Presbyterian system is a very simple system: It assumes that Christians meeting in representative bodies, which we now call **councils**, can seek, and know the will of God and that, through these councils, the whole church can be governed in ways that are just, decent, and orderly.
- Officers elected to serve as commissioners to a meeting of the Presbytery cannot be told how to vote. Our Book of Order reminds us that "Christ alone rules, calls, teaches, and uses the Church as he wills." (F-1.0202)
- Officers must be free to listen for the word of Christ to his church. As commissioners you are independent decision makers and cannot be bound to vote according to the wishes of those who elected you. Again, our Book of Order reminds us that "Presbyters are not simply to reflect the will of the people, but rather to seek together to find and represent the will of Christ." (F-3.0204)
- A meeting of Presbytery is a deliberative body open to the give-and-take of discussion and to the free working of the Holy Spirit.

1 pm, Saturday, April 6 via Zoom

Call to Order – Moderator, Rev. Dr. Brian Henderson called the meeting to order at 1:05 p.m. noting that this meeting serves both as a meeting of the ecclesiastical governing body of the Presbyterian Church (U.S.A.) and a meeting of the Synod of South Atlantic, Inc., a non-profit corporation of the State of Florida.

Acknowledgement of Land & People – *Moderator Henderson* reminded participants that they were asked to visit the link https://native-land.ca/ and learn about the indigenous peoples who were once living on the land. Participants were then asked to enter those tribes/communities of people into the chat, and they were all recognized by the Assembly.

Moderator Henderson opened the meeting with prayer.

Declaration of Quorum – Moderator, Henderson called on Stated Clerk, Valerie Young who declared a quorum with 21 Commissioner present, 11 Ruling Elders and 10 Ministers of the Word and Sacrament of the 31 elected Commissioners, representing at least one-third of the constituent presbyteries of the synod.

COMMITTEE UPDATES & ACTIONS

<u>Report of the Executive Administrative Commission</u> (Attachment A) – In the absence of a Moderator-Elect at this time, Rev. Christina Greenawalt, BFC chair, brought the EAC report.

On behalf of the EAC, it was moved that the Synod Assembly concur with GA Ovt-024 On Creating a General Assembly Administrative Commission on Mid Councils. The motion was APPROVED.

Administration & Relationships - Jeanne Simpson/Bobby Byrd

Bobby Byrd brought a verbal report of the ARC work related to Villa International. He explained that Villa International is an ecumenical mission assisting with housing for employees, students and others working with the CDC and Emory University in Atlanta. In the previous meeting is was stated that the synod holds title to the property and Villa had asked for a transfer of title to them.

The last assembly gave the ARC authority to contact an attorney regarding the synod's responsibilities in this matter. The ARC consulted with an attorney in the Atlanta area and were advised that Villa likely has no argument, and this is not a situation of adverse possession. Villa was contacted by the chair of ARC at the time to convey the response.

Committee on Representation (Attachment B) – Rev. Lisa Martin

The COR moves the election of RE Commissioner, Jacquelyn Rembert from New Harmony Presbytery as Synod Moderator-Elect (2024-2025). Moderator Henderson invited nominations from the floor. Seeing none, the Assembly elected Ms. Rembert unanimously.

The Assembly immediately moved to the Installation of Jacquelyn Rembert as Moderator-Elect.

Ministry Support Committee (Attachment C) – Ken Whitehurst

Ken Whitehurst gave a brief verbal report of the work of MSC regarding grants and a task force working to consolidate and align grants and application deadlines. He then invited *Rev. Caroline Dennis* to bring the report of the Association of Smaller Congregations.

Rev. Dennis, President of the Association of Smaller Congregations referred to the report in the packet. And offered a time of questions and thanked the synod for their support and prayers.

Budget & Finance Committee (Attachment D) – Rev. Christina Greenawalt

Rev. Greenawalt gave a brief report of the work of the BFC in the first quarter.

One behalf of the BFC the motion was made that the Assembly approve the Adjusted 2024 Budget with the changes outlined in the attachment, allowing for the salary adjustments approved previously by the EAC. The motion was APPROVED.

<u>Synod Visioning Task Force Report (Attachment E)</u>

Task Force Members: RE Commissioner, Jacquelyn Rembert (New Harmony Presbytery); Stated Clerk, Rev. Andy James (Greater Atlanta Presbytery); Stated Clerk/TE Commissioner, Rev. Christina Greenawalt (Central Florida Presbytery); General Presbyter, Rev. Danny Murphy (Trinity Presbytery); General Presbyter, Rev. Holly Dillon (Presbytery of Tampa Bay); TE Commissioner, Rev. Jamil El Shair (Savannah Presbytery)

The Visioning Task Force, led by Jacquelyn Rembert and Rev. Andy James, brought a report and presentation of their work together thus far. They explained their next steps for discerning ways in which

the synod can live into the new "Journey Statement" and their hopes and expectations for deep and meaningful conversations with all of those involved with the ministries of the synod.

On behalf of the Visioning Task Force, Jacquelyn Rembert moved that the Synod of South Atlantic approve the attached journey statement, guiding values, and logo as a replacement to the current mission statement and logo and direct the Synod Visioning Task Force to build its continuing work around this document:



Much discussion about the logo happened. Moderator Henderson called for a vote and the motion was APPROVED.

Rev. Andy James, co-chair of the Visioning Task Force, spoke about the next steps and courageous conversations in their work to come.

Motion by Jan Lewis that the synod's Committee on Representation nominate 3 additional Ruling Elders, second, discussion was met with an amendment to the motion by Billie Sutter. Amended motion: that the moderator appoint additional Ruling Elders, accepted by Jan Lewis. Moderator called for unanimous consent to the amendment. The motion was APPROVED.

Treasurer's Report (Attachment F) – Jodi Dodge

Treasurer Dodge spoke about the transition to the accounting firm of Sommerville & Associates, Inc. It has been a little bit of a bumpy start, but staff is working together to establish the best processes for efficiently handling funds disbursements and deposits. Having Annel Belmont as administrative assistant and shared staff with Presbytery of Tampa Bay, has been a real asset to establishing proper accountability processes.

The 2023 audit is complete and provided as an attachment in the packet. There were no issues found.

Moderator Henderson called for a motion to receive the audit. Motion by Christina, second and the motion was APPROVED.

Financial reporting will look different with the transition to new accounting software. Dodge explained some differences in reporting from the old system.

Moderator Henderson called for a motion to receive the financial reports. Motion by Christina Greenawalt, second and the motion was APPROVED.

Christina Greenawalt moved to receive January financial statement. The motion was **APPROVED.**

Report of the Executive & Stated Clerk (Attachment G) - Valerie Young

The denomination has been undergoing major transition over the last decade or so. Even more so lately with the announced changes in the Board of Pensions medical plans and the impacts it is likely to have on congregations and their pastors. It will also have an impact on your mid-council leaders and their benefits, not to mention the presbytery's work to aid their congregations through this transition. This is a stressful time for many. I hope you will be in continued prayer for the leaders and the congregations that they so faithfully serve.

You can read about my travels and ways that I've represented the synod since we last met in November. I have let Presbytery Stated Clerks know that I am available for their pulpit supply lists, subject to the appropriate approval of course. I will be preaching in four places in the coming months and am available, should I be called upon for additional dates. Any honorarium received comes back to the synod and will be reflected on our income statement.

Most importantly, thanks to the excellent work of presbytery stated clerks and PJCs, there has been no business for the synod PJC.

I am elated to be able to report that the reading of the 2022 presbytery minutes is caught up with the completion of Providence Presbytery's contained in your packet. Stated Clerks will be gathering in July for reading of 2023 minutes.

There is quite a bit on the horizon for the synod in addition to the work of the Visioning Task Force:

The first 1st Wednesday, SACK Lunch conversation took place a few days ago and there were about 12 folks from 7 different presbyteries who attended to discuss Youth Ministry in our churches and presbyteries.

There is a SACK Lunch conversation scheduled with a different topic for each of the months remaining in 2024. May 1's conversation is for and about Presbytery Leadership. There is not a week that goes by when I'm not asked, "How do other presbyteries do this?" Now is your chance to ask! How do other presbyteries recruit volunteers? How do other presbyteries design their COM/CPM processes? AND opportunities to share the cool and innovative things that your presbytery is doing. The hope is that we will be able to connect and support each other in our efforts to support our churches.

I have been working with Mark McCain of the SC PDAT (SC PDA) and Kathy Broyard from FLAPDAN (Florida PDA Network) to bring together a series of short webinars on disaster preparation and disaster assistance. Details are still to come – but please be on the lookout!

The synod is preparing for the 226th General Assembly and, with the help of presbytery clerks, will be facilitating GA commissioner training for our presbyteries as well as partnering with presbyteries to hold a lunch in Salt Lake City for commissioners and leaders.

I am proud to be part of a synod where the presbyteries provide such wonderful training and educational opportunities for their members and congregations. The leadership of all 16 presbyteries is strong. . . even and especially where there is no paid leadership. It is an honor to serve in this place and I am grateful for the opportunity to be a part of the Synod of South Atlantic.

The following overtures were presented to the assembly with explanation that the two involving Flint River need to be considered before the synod overture to GA as amendments may be required otherwise.

Moderator Henderson called for a motion to approve the overture from Flint River Presbytery and Presbytery of Greater Atlanta on Lamar County, GA as presented. Motion by Lisa Martin, seconded, and the motion was APPROVED.

Moderator Henderson called for a motion to approve the overture from Flint River Presbytery on Russel County, AL as presented. Motion by Sommer Bowers, second, question was asked about the church and original presbytery having agreed and how the church came to request the move. 

The Winter Stated Meeting of Providence Presbytery met in person at Tirzah Presbyterian Church, York, SC on **February 11, 2024 at 2:30 p.m**. Registration opened at 1:30pm.

CALL TO ORDER

The meeting was Called to Order by the Moderator, **Elder Mike Conn** at 2:30 p.m. with an opening prayer, and he shared the Land Acknowledgement.

Adoption of the Docket and Consent Agenda

Moderator Marty Simmons presented the docket with three amendments: adding greetings from Valerie Young and adding her as a corresponding member, Executive Presbyter of the Synod of the Southeast; adding a report from the Presbytery Executive Search Team; removing the retirement of Rev. Edgar McCall because he was unable to attend due to illness. With those amendments, the docket was approved. Moderator Simmons then placed the Consent Agenda, including the items for action, on the floor. The consent agenda, including items for action 1-6, was approved.

Worship

Moderator Simmons recessed the body for worship. Worship was led by the Worship Team of Rev. Letarshia Robinson, Rev. Rob Jones, Candidate and CRE Paul Smith, and Larry and Jean Rollins. Candidate and CRE Paul Smith led the body with a sermon titled "Hope in a Changing World," Ecclesiastes 3:1-8. At the conclusion of worship, Letarshia Robinson and Marty Simmons lifted in prayer the In Memoriam report of Presbytery elders and pastors who died in 2023 were read. Elders remembered were Lula Covington, Patrick Ussery, James Roqumore, Betty N. Coombs, Dorothy "Dot" Berry, Phillip Griffith, Edward "Ed" Kelly, Buddy Bryant, Jane Watkins, Jane Fredericks, Rachel Tripp, Jon Miller, Helen Grace McCuen Bennett, David (Davd) Emerson Cowan, Mary Marshall (Mim) Whitfield Armour, , Peggy Casey, John Granacher, Margaret Ann Tice, Manly Storme Young III, Zeta Gardner Sistare. Charles Marion

Bullard, Charles August Addison and Josephine Baker. We also remembered CRE William Gaither, Rev. Harold Eller and Rev. Dr. W. T. Holmes.

Bridge Executive Presbyter Report

The Moderator called on the Bridge General Presbyter Toby Mueller. She brought greetings to the body and outlined many of the ways she has been serving. She reported about the recent hiring of Eric Robinson and Katie Rutland and the re-hiring of Rose Lemmons-Berry. She reported that, pending a vote by a church congregation, she will be stepping back from her Bridge Executive Presbyter duties on March 1, though she is available to provide limited service for another few weeks.

Presentation from Implementation Team

The Moderator called on Elder Tim Cureton, chair of the Implementation Team. Tim introduced the Implementation Team and expounded upon the promise that the new Presbytery structure offers. He reported that 515 Oakland Ave. was sold for around \$575,000 (actual price was \$526,852.50). Jason Myers then reported on the process used by the team. They interviewed many people, churches, pastors and committees. Their goal was to create a more agile Presbytery without one designated meeting place. The new structure encourages churches to partner to create and engage new types of ministries. Matt Rich then reported on the structure of the Communities of Care: The Community of Love oversees and implements the ministry strategies of the Presbytery and has the authority to act for the Presbytery between meetings. The Community of Faith offers educational opportunities and resources. It also offers technical resources. The Community of Hope oversees the business and personnel ministries of the Presbytery. The Community of Witness (ministers) resources needs dealing with pastors—those discerning God's call to become pastors, those churches seeking pastors, those congregations having conflicts with pastors, those congregations with more temporary relationships with pastors. The Community of Witness (advocacy) seeks to take the love of God into the community and the world. This community includes existing neighborhoods of ministries which have become important to the ministry of the Presbytery, with more come.

ORDER OF THE DAY

Rev. Shavon Sterling-Louis, Co-moderator of the General Assembly of the PC(USA) brought greetings to the body. She and Bridge Executive Presbyter Toby Mueller engaged in public conversation, through which the body learned more about the state of the PC(USA) and examples of God's throughout the country. Questions to which she responded included: (1) In traveling the country, what has she learned about the Presbyterian Church? (2) With dwindling numbers in the PC(USA), where to you find hope? (3) What troubles you about what you've seen? (4) What is the next big thing in the Presbyterian Church? (5) What issues are we afraid to address? (6) What unique do we have to offer? (7) How are we sometimes complicit in the problem? (8) Where have you seen God's presence on the southern border? (9) What resources are available for small congregations? (10) How does the church engage folks in the 30-40 age range? (11) Is there talk about Youth Advocate Delegates having vote at the GA?

Following the Order of the Day, the body enjoyed a 5-minute break.

Greetings from Rev. Valerie Young

Rev. Valerie Young, Executive Presbyter of the Synod of South Atlantic, brought greetings. She highlighted 3 upcoming events: (1) First Wednesday SACK lunch (2) Sabbath by the pool for women in ministry and (3) a meeting of the Association for Smaller Churches.

Community of Love Report

The Moderator called upon CRE Mike Conn, chair of the Community of Love, for a report. CRE Conn brought attention to the Presbytery e-mail voting policy that was adopted for use by the Community of Love, and he offered it to the other communities and ministry teams for their adoption and use, if so desired. He brought our attention to a document setting out the names to which each community and ministry team will be referred in the new Presbytery structure.

Administrative Commission for the Bethesda (K) church

CRE Conn brought to the floor a motion to approve the following to serve on an Administrative Commission to work with Bethesda Presbyterian Church in Camden regarding their desire to disaffiliate with the PC(USA) and Providence Presbytery: Joanne Sizoo (TE Grace Y), Hope Moore (RE Tirzah Y), Tim McCullough (CRE) Pleasant Ridge, Tom Robinson (retired TE member of Presbytery) and Dannie Vaughn (RE Unity). The motion included authorizing the Administrative Team as follows:

This commission is entrusted with the following authority: (1) to enter conversation with the Bethesda (K) session to determine their reasons for seeking disaffiliation (2) to determine whether the denomination with which the church seeks to affiliate meets the Book of Order criteria for transferring membership (3) to determine whether the church congregation membership supports the desire to disaffiliate from the PC(USA) (as determined by a vote of their active membership of 75% or higher) (4) to determine whether any church members desire to remain members of the PC(USA) and, if so, to work with them to allow them to do so (5) to determine whether there is a schism within the membership of the church congregation and, if so, to take action as set out in G-4.0207 (Book of Order) (6) to inquire into the value of the Church property and assets in order that we do due diligence in our fiduciary responsibility to the PC(USA) (7) to negotiate terms of dismissal with the church session which will be included in a Covenant agreement between Providence Presbytery and Bethesda (K) Presbyterian Church (8) to determine whether the Bethesda congregation accepts the terms of the Covenant agreement (as determined by a vote by their active membership of 75% or higher) (9) if the terms are approved by the congregation, to bring said terms before the body of the Presbytery for vote (10) to take original jurisdiction only if it is determined that the "session of the congregation is unable or unwilling to manage wisely its affairs."

Moderator Simmons opened the floor for questions and discussion. She then asked for the vote, and the motion was approved unanimously.

Presbytery Executive Presbyter Search team

The Moderator called upon Derek Marotta, chair of the Presbytery Executive Presbyter Search team, reported that the team continues their work. Their team has persevered and continued to move forward even through the changes in the direction of their search. They might have a recommendation very soon.

Community of Faith

The moderator called upon Eric Robinson for a report. He reported on four items: (1) partnering with Bethelwoods, confirmation clusters will be available (2) money for scholarships to leadership events are available (3) gatherings for Presbytery educators are upcoming and (4) the Leaderfest event on Mental Health First Aid.

Community of Hope

The moderator called on Hope Moore. Hope thanked Barbara Kurz for her long-time dedication and service to Providence Presbytery. She introduced new Presbytery staff Eric Robinson (Missions Coordinator) and Katie Rutland (Technology and Communications). She reported that Rose Lemmons-Berry was hired for a similar though more limited position as Business Administrator/Treasurer. She referred to and recapped the 2023 finances for the Presbytery and for Bethelwoods, including a deficit in Bethelwoods' budget.

Community of Witness—Ministerial

Retirement of Jane Summey Mullinex

The Moderator called Jane Summey Mullinex forward for her service of retirement. Sarah Davis appeared by Zoom, and she spoke about the meritorious ministry of Jane. Moderator Simmons then led the body on a service of retirement, and she was honorably retired.

Examination of Paul Smith for Ordination

Moderator Simmons invited COM Co-Moderator Susan Bullard continued the team's report. She proceeded with the examination of Paul Smith for ordination as a Minister of the Word and sacrament in the PC(USA). He graduated of Union Presbyterian Seminary in Charlotte, passed his ordination exams and received a glowing recommendation from the CPM and COM. The body received his statement of faith and biography.
